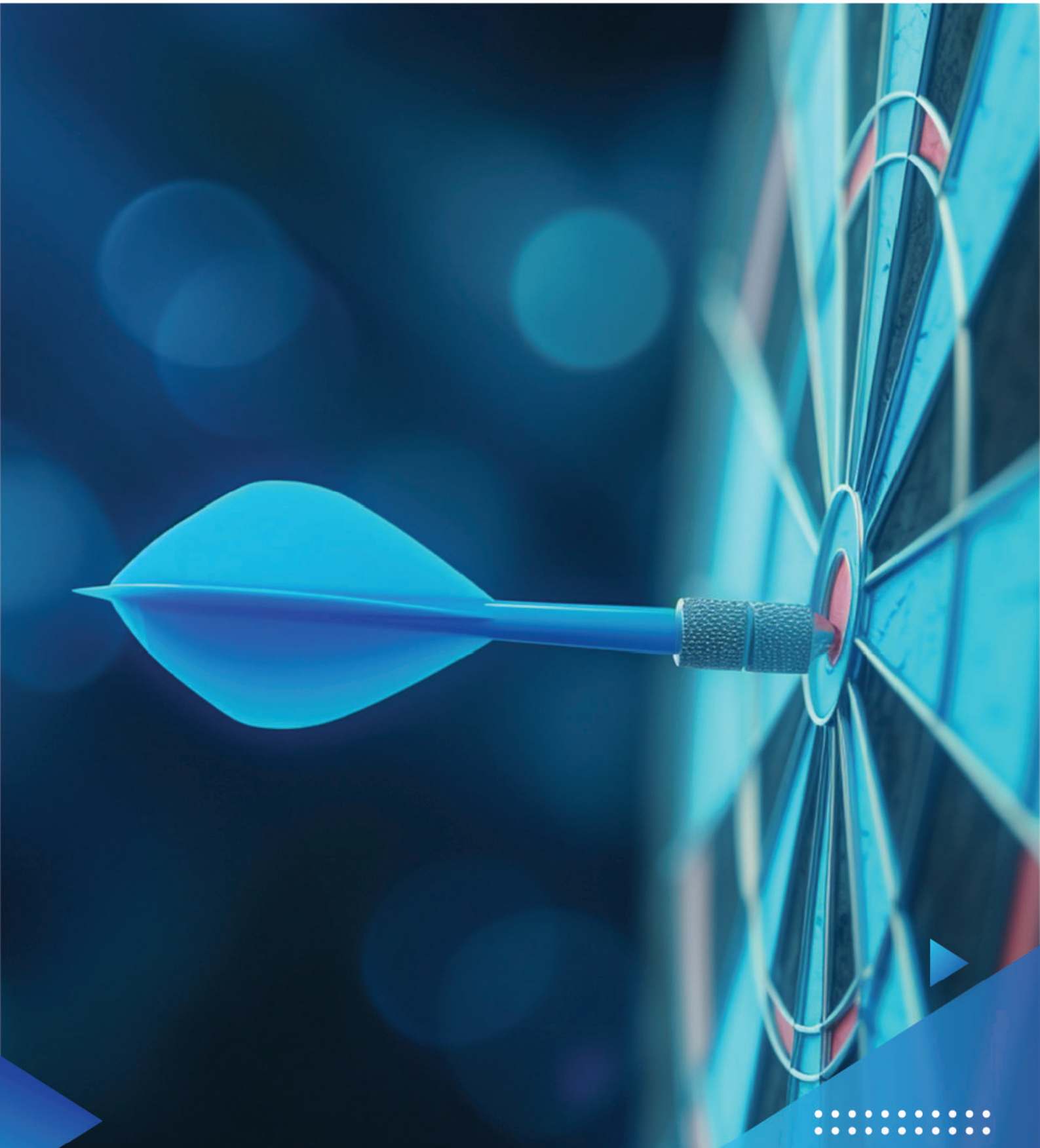

Dear Fellow Inventors,

As someone who understands the thrill of having an idea, the passion to bring it into reality, and the fear of not wanting to make a mistake along the way, I present to you Amar Gite. Amar was an answer to our prayers. After trying to write my own patent, even utilizing the newest AI technology, I was at a loss because of what I didn't know or understand. His clear explanations of various aspects of what makes for 'patentability' helped me clarify my own thinking, until I could clearly articulate to him what I thought was so novel, and fulfilled the other criteria Amar had explained to me. Upon getting to that





degree of specificity, he saw the possibility of success, and we agreed to run a reasonable cost prior art search.

Once I was able to isolate a patentable concept, Amar came back to me with a far more positive disposition, after he confirmed no prior art had significantly covered what was novel in my invention. My wife and I felt comfortable with Amar's estimated percent chance of success, so we agreed to proceed and have now filed our first patent!

During the process, Amar walked us through everything; asking for our review and input each step of the way, and after each draft of the application. Patent writing is a process that requires close communication and full understanding between inventor and attorney, and Amar delivered exquisitely.

And I've learned a lot during our work together. I am far more capable of discerning what does and does not make for patentability, as I now move on to other inventive ideas. And, yes, Amar is our attorney moving forward as we anticipate the stages our first application will go through, and begin a new invention's patenting process. My wife and I are so grateful that GOD had answered our prayers, and given us skilled and honest legal counsel for our invention journey.
